MCD Harrow and Air Seeder Rental Agreement

I agree to the following conditions when using the MCD Harrow and Air Seeder:

- I will assume all responsibility when using the Harrow and Air Seeder
- Upon receipt of the Harrow and Air Seeder, I will complete the rental agreement and contact MCD with the approximate time to needed to complete Harrow and Air Seeder project.
- I will assume all responsibility for the results of the work done with the Harrow and Air Seeder and will not hold MCD responsible for any accidents that may occur while the Harrow and Air Seeder is on my property or in my possession.
- I understand that I am responsible for any damages to the Harrow and Air Seeder.
- The Harrow and Air Seeder must be in as good condition upon return as when it was rented.
- **The instructions will be read, understood, and followed.**
- Renter will pay a \$250 deposit. If the Harrow and Air Seeder sustains any damage, issues will be reported immediately and the repair will be the responsibility of the renter who caused the damage. If equipment is returned in good condition, the deposit amount will be returned to the renter.
- Delays in returning the equipment will be charged at \$200 per day.
- I will not hold MCD responsible for any accidents that may occur, either during transportation or use. I acknowledge that the prevention of accidents arising out of or related to the work is my responsibility. I agree to defend, indemnify, make whole and hold harmless MCD with respect to any and all claims arising out of, related to, or in any manner connected with the use of the Harrow and Air Seeder.

General Instructions for Harrow and Air Seeder Use

In order to rent the Harrow and Air Seeder:

1. Contact the MCD office at **406-682-3181** or email info@madisoncd.org to schedule pick up.
2. Complete and sign the rental agreement **PRIOR TO** use.
3. Provide the estimated dates of use and date of completion of Harrow and Air Seeder project.

If the Harrow and Air Seeder is not clean or in good operating condition, notify MCD for instructions prior to use (406-682-3181).

The Harrow and Air Seeder must be cleaned prior to return to prevent the spread of noxious weeds. This includes removing any twine, wire, net wrap, or weeds that have become stuck in the teeth. Oil the chains and complete any maintenance necessary to return the equipment to the condition in which it was rented.

When transporting the pivot track filler, limit speed to the suggested speed rating. The equipment is not meant to travel at highway speeds.

The total rental charge includes the \$200 per day or \$700 per week fee- no partial day payments are allowed.
